- b. the appointees will be on probation for a period of two years.
 - c. They will report to the Principal concerned within a period of 21 days from the date of issue of this order failing which their appointment will be deemed to have been cancelled without any notice.
 - d. The salary of the appointees will be drawn only after a satisfactory report about their character and antecedents is received from Addl. Director General CID to whom a reference will be made on the prescribed declaration form of the candidate or a certificate of being already in Government service. In case any adverse report is received the appointment (s) will be deemed cancelled without any notice.
 - e. The appointments will also be subject to the outcome of the writ petitions if any are pending in the Hon'ble High Court of J&K.
