Termination of appointment of Mr. Harpreet Singh Raina as Assistant Professor (Zoology) in Higher Education Department.

Whereas, J&K Public Service Commission vide letter No.PSC /DRAsstt.Prof./Zoology/13-14 dated:03-04-2017 recommended Mr. Harpreet Singh Raina S/o Rajinder Singh Raina R/o Village Kassalian Tehsil Haveli District Poonch-185101 for appointment to the post of Assistant Professor (Zoology) under ALC Category in Higher Education Department; and

Whereas, Higher Education Department vide Government Order No.201-HE of 2017 dated 06-04-2017 accepted recommendations of J&K Public Service Commission and appointed Mr. Harpreet Singh Raina as Assistant Professors (Zoology) on regular temporary basis, in pay scale of Rs.15600-39100 with AGP of Rs.6000/. Subsequently, vide Government Order No.280-HE of 2017 dated 19-05-2017 he was posted in Govt. Degree College, Samba; and

Whereas, the Assistant Professor joined in Govt. Degree College, Samba on 25-05-2017 and applied for two days casual leave w.e.f. 26-05-2017 and remained continuously on un-authorized absence from duty; and

Whereas, Principal, GDC, Samba served him Notice dated 17-06-2017 and directed him to report to the College at the earliest otherwise matter shall be reported to the Administrative Department. However, the Assistant Professor failed to respond to the notice; and

Whereas, concerned Principal served another notice dated 22-07-2017 to the Assistant Professor directing him to resume his duties. However, the said Assistant professor did not respond; and

Whereas, Principal GDC, Samba vide letter dated 30-08-2017 reported the matter to Administrative Department and Higher Education Department served Show Cause Notice vide No. Edu-Coll/PF-2005/Elect. dated 15-12-2017 to above said appointee for remaining absent from duty un-authorizedly and asked him to explain as to why action as warranted in terms of Article 128 of the J&K Civil Service Regulations may not be initiated against him, failing which it shall be presumed that he has nothing to say in defence; and

Whereas, Mr. Harpreet Singh did not respond to this notice also;

Whereas, Principal, GDC, Samba vide his letter No.GDC /S/18/565 dated 22.03.2018 informed that above mentioned Assistant Professor has not joined his services even after sufficient opportunity was granted by Administrative Department; and

Whereas, under Rule 22 (1) (b) of J&K CCA, Rules 1956, the probationer is liable to be discharged from service, if not found suitable for membership of the service.

Now, therefore, appointment of Mr. Harpreet Singh Raina S/o Rajinder Singh Raina R/o Village Kassalian Tehsil Haveli District Poonch-185101 (under ALC Category) as Assistant Professors (Zoology) in Higher Education Department is hereby terminated with immediate effect.
