- a. the appointees shall, at the time of joining, produce following testimonials in original to be verified by the Principal concerned before formally allowing them to join:
  - i. Permanent Resident Certificate.
  - ii. Date of Birth Certificate.
  - iii. Qualification Certificates i. e. NET/SLET/Ph.D.
  - iv. A certificate from the Director Employment that the candidate has liquidated the loan, if he/she taken.
- b. appointees will be on probation for a period of two years.
- c. they will report to the Principal concerned within a period of 21 days from the date of issue of this order failing which their appointment shall be deemed to have been cancelled without any notice.
- d. The salary of the appointees will be drawn only after a satisfactory report about their character and antecedents is received from Addl. Director General CID to whom a reference will be made on the prescribed declaration form of the candidate or a certificate of being already in Government service. In case any adverse report is received the appointment (s) will be deemed cancelled without any notice.


