Subject: Appointment of Mr. Jameel Ahmed as Assistant Professor (Sociology) and cancellation of appointment of Ms. Farida Batool as Assistant Professor (Sociology).
Reference: Letter No.PSC/DR/Lit/178/2017 dated 16-10-2017 from J&K, PSC.

Whereas, J&K Public Service Commission vide letter No.PSC/DR/Asstt. Prof /Sociology/13-14 dated 01-06-2017 recommended 53 candidates under (OM=29, RBA=11, SC=05, ST=05, ALC=2 & SLC 01) for appointment to the posts of Assistant Professors (Sociology) in Higher Education Department and accordingly appointment Orders were issued by this Department vide Govt. Order No.342-HE of 2017 dated 12-06-2017; and

Whereas, the appointees were posted by this Department in various Government Degree Colleges of State vide Govt. Order No.394-HE of 2017 dated 03-07-2017; and

Whereas, Higher Education Department received a communication bearing No. PSC/DR/Lit/178/2017 dated 16-10-2017 from J&K, Public Service Commission, Jammu, whereunder, it has been informed that the Commission received an RTI application from one candidate namely Sh. Jameel Ahmad, who among mother candidates, was also interviewed for the said post under the ST category, seeking break-up of his total merit points of 52.17. During the process of providing information to the applicant, the Commission observed that the information seeker inadvertently has not been awarded 05 points on account of weight-age accrued on his basic qualification while calculating his overall merit points. The previous merit of the candidate was 52.72 and after adding 05 points more of basic qualification, his overall merit has scaled to 57.17. Thus, after making necessary correction, he figures in the selection zone at S. No.3 after Mr. Haider Ali Ashkay by exclusion of Ms. Farida Batool, figuring at S. No.05, under ST Category in the selection list, who has secured 52.18 points; and

Whereas, Public Service Commission has now withdrawn recommendations in favour of Ms. Farida Batool D/o Mohd Hanif C/o Lala Mohindra Shop Balkhang, Main Bazar, Leh and has recommended Mr. Jameel Ahmed S/o Abdul Kareem R/o Chhungan, Tehsil Mendhar, District Poonch for appointment to the post of Assistant Professor (Sociology) in Higher Education Department. However, Ms. Farida Batool shall figure at S. No.1 in the wait list.

Now, therefore, in view of the above given facts and recommendations furnished by J&K, Public Service Commission, Jammu, sanction is hereby accorded to the:

- I. Cancellation of appointment of Ms. Farida Batool D/o Mohd Hanif C/o Lala Mohindra Shop Balkhang, Main Bazar, Leh, presently posted as Assistant Professor (Sociology) Govt. Degree College, Budgam. (under ST Category).
- II. Appointment of Mr. Jameel Ahmed S/o Abdul Kareem R/o Chhungan, Tehsil Mendhar, District Poonch as Assistant Professor (Sociology) in Higher Education Department on regular temporary basis in the pay scale of R.15600-39100 with AGP of Rs.6000/- under (ST category). **He is posted in Govt. Degree College, Mendhar.**

The appointment of Mr. Jameel Ahmed shall be subject to following conditions:

- a. that he shall, at the time of joining, produce following testimonials in original to be verified by the Principal concerned before formally allowing him, to join:
 - i. Permanent Resident Certificate /Category Certificate.
 - ii. Date of Birth Certificate.
 - iii. Qualification Certificate i.e. NET/SLET/Ph.D.
 - iv. A certificate from the Director Employment that the candidate has liquidated the loan, if availed.
- b. that he will be on probation for a period of two years.
- c. that he will report to the Principal concerned within a period of 21 days from the date of issue of this order failing which his appointment will be deemed to have been cancelled without any notice.
- d. that his salary will be drawn only after a satisfactory report about his character and antecedents is received from Addl. Director General CID to whom a reference will be made on the prescribed declaration form of the candidate or a certificate of being already in Government service. In case any adverse report is received the appointment will be deemed cancelled without any notice.
- e. that his appointment will also be subject to the outcome of the writ petitions if any pending in the Hon'ble High Court of J&K.
