- 5. Relevant Category Certificate (in case the candidate belongs to Reserved Category).
- 6. Certificate from General Manger, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any scheme.



In case any appointee fails to join within the stipulated period of 21 days, his/her appointment shall be cancelled without any further notice.

The appointment shall be subject to the following conditions:

- a) The appointee shall give an undertaking duly attested by a Judicial Magistrate, to the effect that in case adverse report about his/her character and antecedents is received from the Inspector General of Police, CID, Jammu and Kashmir, to whom a reference shall be made by the Department, his/her appointment shall be deemed to be cancelled ab-initio and he/she shall have no claim on his/her appointment.
- b) The verification of qualification/reserved category certificate (wherever applicable) from the concerned quarters/issuing authority.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) and (b) above is received.

The appointment of above candidates shall, however, be subject to outcome of writ petition if any pending in any court of law. The candidates shall be on probation for a period of two years from the date of joining into Government Service and the Seniority of the appointee shall be maintained as per merit/list furnished by the SSRB.
