As recommended by J&K Public Service Commission, sanction is hereby accorded to appointment of Ms. Jahan Ara W/o Tufail Qayoom Shah R/o 88-AI Farooq Colony Rawalora Bypass Srinagar under Open Merit as Assistant Professors in Functional English on regular temporary basis, in pay scale of Rs.15,600-39,100 with AGP of Rs.6000/- in Higher Education Department and she is posted in A.S. College, Srinagar against an available post.

Her appointment shall be subject to following conditions:

- a. the appointee shall, at the time of joining, produce following testimonials in original to be verified by the Principal concerned before formally allowing them to join:
  - i. Permanent Resident Certificate.
  - ii. Date of Birth Certificate.
  - iii. Qualification Certificates i. e. NET/SLET/Ph.D.
  - iv. A certificate from the Director Employment that the candidate has liquidated the loan, if she taken.
- b. Appointee will be on probation for a period of two years.
- c. Appointee shall report to the Principal concerned within a period of 21 days from the date of issue of this order failing which her appointment will be deemed to have been cancelled without any notice.
- d. The salary of the appointee will be drawn only after a satisfactory report about her character and antecedents is received from Addl. Director General CID to whom a reference will be made on the prescribed declaration form of the candidate or a certificate of being already in Government service. In case any adverse report is received the appointment (s) will be deemed cancelled without any notice.
- e. If on verification, at any time, the certificate produced by the appointee prove fake or forged, the appointment shall be treated as cancelled ab-initio.


The appointment will also be subject to the outcome of the writ petitions if any are pending in the Hon'ble High Court of J&K.
