Whereas, J&K Public Service Commission, vide letter No. PSC/ DR/AP/ Commerce/13-14 dated 07-02-2017, recommended following candidates for appointment as Assistant Professors (Commerce) in Higher Education Department;

Whereas, J&K Higher Education Department vide Government Order No.106-HE of 2016 dated 15-02-2017, accepted recommendations of J&K, Public Service Commission and appointed above mentioned candidates as Assistant Professors (Commerce) on regular temporary basis, in pay scale of Rs.15600-39100 with AGP of Rs.6000/- and posted them in Govt. Degree College, Shopian, SPMR College of Commerce, Jammu and Govt. Degree College, Rajouri, respectively; and

Whereas, Administrative Department had directed the said appointees to join their services within 21 days from date of issuance of appointment order, failing which their appointment shall be deemed to have been cancelled without any notice; and

Whereas, Nodal Principal, A.S. College, Srinagar has intimated that Sh. Tamseer-ul Ishaq, Assistant Professor (Commerce) appointed vide Govt. Order No.106-HE of 2017 dated 15-02-2017 did not join at his place of posting i.e. GDC, Shopian till date. Further, Nodal Principal, GGM Science College, Jammu vide his letter dated 10-04-2017 has also intimated that Ms. Jyoti Sharma and Rishi Kumar, Assistant Professors (Commerce) appointed vide Govt. Order No.106-HE of 2017 dated 15-02-2017 did not join at places of postings i.e. SPMR College of Commerce, Jammu and Govt. Degree College, Rajouri till date; and

Whereas, this Department served a Notice vide No.HE-Coll/Appt/AP/Commerce/2017 dated 07-06-2017 to above said appointees with directions to join their respective places of postings within a period of 15 days from the date of receipt of Notice or its publication in local daily, whichever happens earlier, failing which their appointment shall be deemed to have been cancelled without any further notice. The notice was also uploaded on official website of Higher Education Department; and

Whereas, Principal, GDC, Shopian, GDC, Rajouri and SPMR College of Commerce, Jammu have again informed that above mentioned Assistant Professors have not joined their services even after sufficient opportunity was granted by Administrative Department.

Now, therefore, appointment of Sh. Tamseer-ul-Ishaq S/o Mohammad Ishaq Mir R/o Woyen, Imamsahib, Shopian, Ms. Jyoti Sharma D/o Om Prakash Sharma R/o Plot No.29, Resham Ghar Colony, Jammu and Sh. Rishi Kumar S/o Bal Krishan R/o Dharara BPO Shiva P/O Puldoda, Doda, as Assistant Professors (Commerce) in Higher Education Department is hereby cancelled.
