Subject:- Cancellation of appointment of Sh.Sandeep Dubey and Sh.Padam Dev Singh as Assistant Professor (Dogri) in Higher Education Department.

Whereas, J&K Public Service Commission vide letter No. PSC/DR/Dogri/Asstt.Prof/2014 dated 09-03-2016 recommended Sh.Sandeep Dubey S/o Kuldeep Kumar Sharma R/o W.No. 01, Chigli Chowri Ramanagar, District Udhampur and Sh. Padam Dev Singh s/o Shiv Dev Singh R/o H.No. 301, Lane No. 05, Lakkar Mandi, Janipur, Jammu for appointment as Assistant Professor (Dogri) in Higher Education Department.

Whereas, J&K Higher Education Department vide Government Order No. 227-HE of 2017 dated 18-04-2017, accepted recommendations of J&K, Public Service Commission appointed them as Assistant Professor (Dogri), on regular temporary basis, in pay scale of Rs.15600-39100, with AGP of Rs.6000/- and posted them in Government Degree College for women, Udhampur and Govt. Degree College, Akhnoor respectively;

Whereas, Administrative Department had directed said appointees to join their service within 21 days from the date of issuance of appointment order failing which their appointment shall be deemed to have been cancelled without any notice;

Whereas, the Nodal Principal, GGM Science College, Jammu vide letter No. GGM/Sc/Coll/84 dated 20-05-2017 informed that Mr. Sandeep Dubey and Mr. Padam Dev Singh have not joined their services within prescribed time period;

Whereas this Department served a Notice vide No. HE-Coll/Aptt/A.P.104/Dogri/2017 dated 04-07-2017 to Sh. Sandeep Dubey and Sh. Padam Dev Singh, with the directions to report to Principal, Govt. Degree College for Women, Udhampur and Govt. Degree College, Akhnoor within a period of 15 days from the date of publication notice in local News Paper/hoisting on official website of Higher Education Department, whichever happens earlier, failing which their appointment shall be cancelled without any further notice;

Whereas, Principal, Govt Degree College for Women, Udhampur has informed that Dr. Sandeep Dubey has furnished writing statement that he is no more interested to join the Job. Moreover the Principal, Govt. Degree College, Akhnoor has informed that Shri Padam Dev Singh has not joined his duties till date;

Now, therefore, appointment of Sh.Sandeep Dubey S/o Kuldeep Kumar Sharma R/o W.No. 01 Chigli Chowri Ramanagar, District Udhampur and Sh. Padam Dev Singh s/o Shiv Dev Singh R/o H.No. 301, Lane No. 05, Lakkar Mandi, Janipur, Jammu ordered by the Department vide Government Order No. 227-HE of 2017 dated 18-04-2017 as Assistant Professors (Dogri) in Higher Education Department is hereby cancelled.
