**Subject: Cancellation of appointment of Ms. Mamta and Mr. Fayaz Ahmad Bhat as Assistant Professors (Environmental Science) in Higher Education Department.**

Whereas, J&K Public Service Commission vide letter No.PSC/DR/AP/Evs13-14 dated 17-02-2017 recommended Ms. Mamta, D/o Bal Krishan Bhat,H.No.393-A, Sushel Nagar,Extension Talab Tiloo Camp, Jammu (Open Merit) and Mr. Fayaz Ahmad Bhat S/o Ghulam Rasool Bhat R/o H.No.73, New Colony Rajwara Road, Handwara, Kupwara (R.B.A. Category) for appointment as Assistant Professor (Environmental Science) in Higher Education Department; and

Whereas, J&K Higher Education Department vide Government Order No.114-HE of 2017 dated 21-02-2017, accepted recommendations of J&K Public Service Commission and appointed above said candidates as Assistant Professors (Env. Science), on regular temporary basis, in pay scale of Rs.15600-39100 with AGP of Rs.6000/- and with the direction to report to Nodal Principal, A.S. College, Srinagar/GGM Sc. College, Jammu within a period of 21 days from date of issuance of appointment order, failing which their appointment shall be cancelled without any notice; and

Whereas, vide Government Order No.169-HE of 2017 dated 24-03-2017 the above said appointees were posted at Govt. Degree College, Reasi, and Govt. Degree College for Boys, Sopore respectively; and

Whereas, Nodal Principal, A.S. College, Srinagar and Nodal Principal, GGM Science College, Jammu intimated that the above said appointees failed to join their services within prescribed time even after opportunity granted by this Department vide Notice No.HE-Coll/Apptt./A.P./Evs/2017 dated 24-04-2017 and as such the posts are still lying vacant; and

In view of above the appointment of Ms. Mamta, D/o Bal Krishan Bhat,H.No.393-A, Sushel Nagar,Extension Talab Tiloo Camp, Jammu (Open Merit) and Mr. Fayaz Ahmad Bhat S/o Ghulam Rasool Bhat R/o H.No.73, New Colony Rajwara Road, Handwara, Kupwara (R.B.A. Category) as Assistant Professors (Env. Science) in Higher Education Department is hereby cancelled.
