In terms of J&K Compassionate Appointment Rules, 1994 notified vide SRO-43 of 1994 dated 22-02-1994, sanction is hereby accorded to the temporary appointment of Mr. Shivam Manhas S/o. Sh. Om Raj Manhas & Late Smt. Meenakshi Kotwal (Ex- Assistant Professor) R/o. A-1 Old Ahata Amar Singh Panjtirthi, Jammu as Junior Assistant in the pay band of Rs.5200-20200 with grade pay of Rs. 1900/- in Higher Education Department (Divisional Cadre Jammu) in relaxation of technical qualification (i.e Six months computer course and typing) in terms of Rule-7 under SRO-43 of 1994, subject to the condition that the appointee shall have to acquire six months computer course and qualify the type test with a speed of 35 words per minute during the period of probation to be conducted by the concerned HOD.

Appointee shall be on probation for a period of two years from the date of joining into Government service. He shall has to undergo and qualify the Secretariat Assistant Examination/Training during the period of his probation.

Further, appointee is adjusted in Government College of Engineering & Technology, Jammu. He shall report to Principal, Government College of Engineering & Technology, Jammu within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/ certificates to be verified subsequently:-

1. Academic Qualification Certificates.
2. Date of Birth Certificate.
3. Health Certificate issued by the Competent Authority.
4. Permanent Resident Certificate.
5. Dependent certificate issued by Assistant Commissioner (Revenue).
6. Certificate from General Manger, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme

In case appointee fail to join within the stipulated period of 21 days, his appointment shall be cancelled without any further notice.

The appointment shall be subject to the following condition.

- a) The appointee shall give an undertaking duly attested by a Judicial Magistrate, to the effect that in case adverse report about his character and antecedents is received from the Inspector General of Police CID, Jammu and Kashmir to whom a reference shall be made by the department, his appointment shall be deemed to be cancelled ab-initio and he shall have no claim on his appointment.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) above is received.

Further, if on verification, at any time, the certificates produced by the appointee prove fake or forged, the appointment shall be treated as cancelled ab-initio.
