In continuation to Government Order No.384-HE of 2016 dated 23-12-2016, sanction is hereby accorded to appointment of **Kainat D/o Suna Ullah Mir R/o Kalmunah Tehsil Handwara District Kupwara** under **(RBA Category)** as Assistant Professor in Philosophy on regular temporary basis, in the pay band of Rs.15,600-39,100 with A.G.P. of Rs. 6000/- in the Higher Education Department.

Appointee shall report to the Nodal Principal, A.S. College, Srinagar for undergoing training programme alongwith the other newly appointed Assistant Professors in Philosophy being organized in the College of Education, Srinagar.

The appointment of candidate shall be subject to condition that:

- a. the appointee shall, at the time of joining, produce following testimonials in original which will be verified by the Principal concerned before formally allowing him to join:
 - i. Permanent Resident Certificate.
 - ii. Date of Birth Certificate.
 - v. Qualification Certificates i. e. NET/SLET/Ph.D.
 - vi. A certificate from the Director Employment that the candidate has liquidated the loan, if he taken.
- b. Appointee shall be on probation for a period of two years.
- c. he shall report to the Principal concerned within a period of 21 days from the date of issue of this order failing which his appointment will be deemed to have been cancelled without any notice.
- d. The salary of the appointee will be drawn only after a satisfactory report about his character and antecedents is received from Addl. Director General CID to whom a reference will be made on the prescribed declaration form of the candidate or a certificate of being already in Government service. In case any adverse report is received the appointment will be deemed cancelled without any notice.

The appointment will also be subject to the outcome of the writ petitions if any are pending in the Hon'ble High Court of J&K.
