Subject: Cancellation of appointment of Assistant Professors (Political Science) in Higher Education Department.

Whereas, J&K Public Service Commission vide letter No. PSC/DR/Asstt.Prof./Political Science/13-14 dated 14-06-2017 recommended Mr. Reyaz Ahmad Ganaie S/o Gh. Ahmad Ganaie R/o Shirpora, Pattan Tehsil Pattan Distt. Baramulla (under) Open Merit Category) among others for appointment as Assistant Professor (Political Science) in Higher Education Department; and

Whereas, J&K Higher Education Department vide Government Order No.376-HE of 2017 dated 20-06-2017 accepted recommendations of J&K Public Service Commission and appointed him as Assistant Professor (Political Science) on regular temporary basis, in pay scale of Rs.15600-39100 with AGP of Rs.6000/- and with the direction to report to Nodal Principal, A.S. College, Srinagar within a period of 21 days from date of issuance of appointment order failing which your appointment shall be deemed to have been cancelled without any notice; and

Whereas, vide Government Order No.418-HE of 2017 dated 17-07-2017 he have been posted at Govt. Degree College, Pattan; and

Whereas, Nodal Principal, A.S. College, Srinagar vide her letter No.ASC/Edu/17/1543 dated 08-08-2017 has intimated that above Assistant Professor has not joined his services within prescribed time and as such the post is lying vacant; and

Whereas, this Department served a Notice vide HE-Coll/Appt./A.P./Pol. Science /2017 dated 25-09-2017 to above said appointee with directions to join his place of posting within a period of 10 days from the date of receipt of Notice or its publication in local News paper uploading on official website of Higher Education Department, whichever happens earlier, failing which his appointment shall be cancelled ab-initio without any further Notice; and

Whereas, Principal, GDC, Pattan informed that above mentioned Assistant Professor has not joined his services even after sufficient opportunity was granted by Administrative Department.

Now, therefore, appointment of Mr. Reyaz Ahmad Ganaie S/o Gh. Ahmad Ganaie R/o Shirpora, Pattan Tehsil Pattan Distt. Baramulla (under Open Merit Category) as Assistant Professors (Political Science) in Higher Education Department is hereby cancelled.




