Whereas, J&K Public Service Commission, vide letter No. PSC/DR/Asstt.Prof./Economics/13-14 dated 19-05-2017, recommended following candidates for appointment as Assistant Professors (Economics) in Higher Education Department;

Whereas, J&K Higher Education Department vide Government Order No.302-HE of 2017 dated 31-05-2017, accepted recommendations of J&K, Public Service Commission and appointed above mentioned candidates as Assistant Professors (Economics) on regular temporary basis, in pay scale of Rs.15600-39100 with AGP of Rs.6000/- with the direction to report to Nodal Principal, GGM Science College, Jammu within a period of 21 days from date of issuance of appointment order failing which their appointment shall be deemed to have been cancelled without any notice; and

Whereas, vide Government Order No.374-HE of 2017 dated 20-06-2017 the above said appointees were posted at Govt. Degree College, R.S. Pura and Govt. Degree College, Billawar respectively; and

Whereas, Nodal Principal, GGM Science College, Jammu vide his letter No.GGM/Sc/Coll/3825-II dated 10-08-2017 intimated that above appointees did not join their services within prescribed time and as such the posts are lying vacant; and

Whereas, this Department served a Notice vide HE-Coll/Apptt./A.P./Economics/2017 dated 25-09-2017 to above said appointees with directions to join their respective places of postings within a period of 10 days from the date of receipt of Notice or its publication in local News paper uploading on official website of Higher Education Department, whichever happens earlier, failing which their appointment shall be cancelled ab-initio without any further Notice; and

Whereas, Principal, Govt. Degree College, R.S. Pura and Govt. Degree College, Billawar have again informed that above mentioned Assistant Professors have not joined their services even after sufficient opportunity was granted by Administrative Department.
