As recommended by J&K Public Service Commission, sanction is hereby accorded to appointment of Mr. Ashwani Kumar S/o Kunj Lal, R/o Bhatoli A/P Kharangal Tehsil Bhalessa District Doda, under RBA Category, as Assistant Professor (Zoology), on regular temporary basis, in pay scale of Rs.15,600-39,100 with AGP of Rs.6000/- in Higher Education Department. He is posted in Govt. Degree College, Bhaderwah. He shall figure at Sr. No.02 under RBA Category i.e. after Mohd Anis Ganaie and before Reetika Rani in the select list of Govt. Order No.201-HE of 2017 dated 06-04-2017..

His appointment shall be subject to following conditions:

- a. Appointee shall, at the time of joining, produce following testimonials in original to be verified by the Principal concerned before formally allowing him to join:
 - i. Permanent Resident Certificate.
 - ii. Date of Birth Certificate.
 - iii. Qualification Certificates i. e. NET/SLET/Ph.D.
 - iv. A certificate from the Director Employment that the candidate has liquidated the loan, if he taken.
- b. Appointee shall be on probation for a period of two years.
- c. Appointee shall report to the Principal concerned within a period of 21 days from the date of issue of this order failing which his appointment will be deemed to have been cancelled without any notice.
- d. Salary of appointee will be drawn only after a satisfactory report about his character and antecedents is received from Addl. Director General CID to whom a reference will be made on the prescribed declaration form of the candidate or a certificate of being already in Government service. In case any adverse report is received the appointment will be deemed cancelled without any notice.
- e. If on verification, at any time, the certificate produced by the appointee prove fake or forged, the appointment shall be treated as cancelled ab-initio.
- f. The appointment will also be subject to the outcome of the writ petitions if any pending in the Hon'ble High Court of J&K.
