
As recommended by J&K, Service Selection Board, sanction is hereby accorded to appointment of Ms. Sapna Bhat D/o. Romesh Chander R/O Moothi Doda as Junior Laboratory Assistant (Divisional Cadre Jammu) on regular temporary basis in the pay scale of Rs. 5200-20200+GP 1900 in Higher Education Department. She is adjusted in Govt. Degree College, Bhaderwah against an available post.

She shall report to Principal, Govt. Degree College, Bhaderwah within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarters:-

1. Academic/Technical Qualification Certificates.
2. Date of Birth Certificate.
3. Health Certificate issued by the Competent Authority.
4. Permanent Resident Certificate.
5. Certificate from General Manger, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.

The appointment shall be subject to the following conditions.

- a) The appointee shall give an undertaking duly attested by a Judicial Magistrate, to the effect that in case adverse report about her character and antecedents is received from the Inspector General of Police CID, J&K to whom a reference shall be made by the department, her appointment shall be deemed to be cancelled ab-initio and she shall have no claim on her appointment.
- b) The verification of qualification/ reserved category certificate (wherever applicable) from the concerned quarters/issuing received.
- c) Further, if on verification, at any time, the certificates produced by the appointee prove fake or forged, the appointment shall be treated as cancelled ab-initio.
- d) Appointment of above candidate shall also be subject to outcome of writ petition, if any pending in any court of law.



- e) She shall be on probation for a period of two years from the date of joining into Government service and the seniority of the appointee shall be maintained as per merit list furnished by the Service Selection Board.

Salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) and (b) above is received.
