Subject: Suspension of Mr Abdul Rashid Wani, Section Officer, Higher Education Department.

Government Order No. 560 HE of 2017.
D a t e d: 25 -09- 2017.

Whereas, Mr Abdul Rashid Wani, Section Officer, Higher Education Department was working in Higher Education (Administrative) Department and was transferred & posted in GDC, Pampore vide Office Order No. 47-HE of 2017 dated 15.05.2017 and was relieved with immediate effect to report for further duties to Principal, GDC Pampore; and

Whereas, Mr. Abdul Rashid Wani, Section Officer did not bother to join his new place of posting i.e. in GDC, Pampore; and

Whereas, the official was placed under suspension with immediate effect in terms of Rule 31 of J&K Civil Services (Classification Control & Appeal) Rules 1956 vide Government Order No. 343-HE of 2017 dated 12.06.2017 for his failure to join at GDC, Pampore within stipulated time; and

Whereas, Director Colleges, Higher Education Department was directed to investigate the un-authorized absence of Mr. Abdul Rashid Wani, SO, from duties and asked to suggest disciplinary action as per law; and

Whereas, Director Colleges, Higher Education Department vide letter No. PS/DC/Misc/Compl/2017 dated 28.06.2017 furnished preliminary enquiry report in an attempt to exonerate the official from the charges, however, the credentials of the official are extremely doubtful as he was involved in sensitive issues like service matters and transfers of Higher Education Department employees; and

Whereas, the recommendations furnished by Director Colleges, HED are vague & cryptic and has arbitrarily absolved the official for his negligence towards his duties;

Whereas, the matter needs to be referred to some independent investigating agency to keep a watch over the official and providing inputs thereof; and

Now therefore, it is hereby ordered that the official should not be posted at any time in the Administrative Department in future. Even in normal course wherever he is posted he should not be given any sensitive assignment pertaining to financial and administrative matters.
