Further, the above said employees shall be adjusted in Cluster University Jammu against available vacancies for further duties.

The regularization of the candidates shall be subject to the fulfillment of following conditions failing which their appointment shall be deemed to have been cancelled ab-inito:-

1. The candidate shall be within the age group of entry into Government Service as on the date of his/her initial engagement as local fund employee in the College.
2. The appointment of the candidates shall be subject to the production of original qualification certificates/testimonials.
3. Work and Conduct Certificate during the period of his service as Local Fund Employee issued by Principal of the concerned College.
4. The candidates shall join their respective place of postings within 21 days from the date of issuance of this order.
5. The regularization order shall be without prejudice to the final outcome of any writ petition, if any, pending in the competent court of Law. Further, if on verification at any time, the certificates produced by the candidates to be prove fake or forged, the regularization of these candidates shall be treated as cancelled ab-inito.
6. The candidate shall given an undertaking duly attested by a Judicial Magistrate, to the effect that in case adverse report about their character and antecedents is received from the Inspector General of Police CID J&K to whom a reference shall be made by the department, their regularization shall also be deemed to be cancelled and they have no claim on their regularization.

The Concerned Registrar of Cluster University Jammu shall verify the original certificates/testimonials as well as other requisite documents before allowing them to join.
