Subject:- Revocation of suspension in favour of Ms. Ashu Jolly, Assistant Professor (Education), Government College of Education, Jammu.

Govt. Order No:- 485 -HE of 2018

Whereas, Ms. Ashu Jolly, Assistant Professor in Education was taken into custody by Vigilance organization on 09-12-2-2016 and detained for more than 48 hours, as intimated vide letter No. COE/J/2415-16 dated 14-12-2016 by Principal, Government College of Education, Jammu;

Whereas, vide Government Order No. 03-HE of 2017 dated 02-01-2017, Ms. Ashu Jolly, Assistant Professor of Government College of Education, Jammu was placed under suspension w.e.f. 09-12-2016;

Whereas, Ms. Ashu Jolly filed the SWP No. 2705/2017 in the Hon'ble High Court and in MP No. 1/2017, the Hon'ble Court vide order dated 17-11-2017 directed as under:

"in view of the above said submission and taking in to the account the Government instructions No. 2 appended to rule 31 of the Rules, 1956 as well as with a view to maintain parity, it is directed that operation and effect of order of suspension dated 02-01-2017 shall remain stayed till next date of hearing".

Whereas, the case was referred to General Administration Department vide U.O No. HE-Coll/PF-2013/01 dated 19-03-2018 for their opinion in the matter and the General Administration Department vide U. O. No. GAD(Vig)24-SP/2017 dated 28-03-2018 advise as under:

"the investigation in case FIR No. 25/2016 P/S VOJ in which Ms. Ashu Jolly is involved has been completed and prosecution sanction stands granted by the competent authority. As the Hon'ble Court has passed directions on 17-11-2017 that operation and effect of order of suspension shall remain stayed, so, there is no legal impediment in

revoking the suspension order of the accused office. The concerned Department in revoking the suspension order of the accused officer. The concerned Department is competent to revoke suspension order of Ms. Ashu Jolly, Assistant Professor, Government College of Education, Jammu with the condition that the intervening period of her suspension shall be decided after conclusion of court proceedings against her".

Now, therefore, keeping in view of the direction of Hon'ble High Court in SWP No. 2705/2017 and the advice of the General Administration Department, the suspension of Ms. Ashu Jolly, Assistant Professor (Education), Government College of Education, Jammu is here by revoked with immediate effect and the suspension period shall be decided after conclusion of legal proceedings. Ms. Ashu Jolly shall report to the Principal, Govt. College of Education, Jammu for duties.


