In terms of J&K Compassionate Appointment Rules, 1994 notified vide SRO-43 dated 22-02-1994, as amended from time to time, sanction is hereby accorded to the temporary appointment of Mr. Samee Ullah Wani S/O (Sona Ullah Wani) B/O Late Altaf Ahmad Wani (Ex- Lecturer) R/O Hajin Sonawari , District Bandipora as Junior Assistant in the pay Band of Rs. 5200-20200 with Grade Pay of Rs. 1900/- in the Higher Education Department (Divisional Cadre, Kashmir) in relaxation of technical qualification (i.e Six months computer course and typing) in terms of rule-7 of SRO-43 of 1994.

The above appointment is subject to the condition that the appointee shall have to acquire six months computer course and qualify the type test with a speed of 35 words per minute during the period of probation to be conducted by the concerned Principal.

The appointee is adjusted in Government Degree College, Ganderbal against an available vacancy and shall report to the concerned Principal of the College within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificate to be verified subsequently:-

1. Academic/Technical Qualification Certificate.
2. Date of Birth Certificate.
3. Health Certificates issued by the Competent Authority.
4. Permanent Resident Certificate.
5. Certificate from General Manager, DIC concerned and Deputy Director Employment concerned to the effect that no loan has been taken by the candidates under any Scheme.

In case appointee fails to join within 21 days, his appointment shall be cancelled without any further notice.

The appointment shall be subject to the following condition:-

- a) Appointee shall give an undertaking duly attested by the Judicial Magistrate, to the effect that in case of adverse report about his character and antecedents is received from Inspector General of Police CID, J&K to whom a reference shall be made by the department, his appointment shall be deemed to be cancelled ab-initio and shall have no claim on his appointment.
- b) Salary of the appointee shall not be drawn and disburse unless a satisfactory report in respect of (a) is received.
- c) The appointee shall be initially on probation for a period of two years, if on verification, the certificate(s) produced by the appointee prove to be fake or forged, the appointment shall be cancelled ab-initio.
