In partial modification of Government Order No. 159-HE of 2008 dated 07-07-2008 issued under endorsement No. HE/Recog/BCA/IMI/122/2005 dated 07-07-2008 enteries "A", "B", "C", "D" & "E" appearing after  $2^{nd}$  last para of the said Government Order are re-caste as under:-

A. An inspection fee of Rs. 25000/- (Non refundable) per institution shall be deposited by the promoter alongwith the application form for conduct of inspection pledged to the FA/CAO, Higher Education Department which shall be credited to the account Head 0202-Gen Education in the Higher Education Department.

B. An amount of Rs. 10000/- (Non-refundable) per courses shall be charged as inspection fee for inspection in respect of request for grant of additional courses in the existing authorized institutions. The said amount shall also be pledged to the FA/CAO, Higher Education Department which shall be credited to the account Head 0202-Gen Education in the Higher Education Department.

C. An amount of Rs. 10000/- (Non-refundable) per courses shall be charged as reinspection fee for re-inspection. The said amount shall also be pledged to the FA/CAO, Higher Education Department which shall be credited to the account Head 0202-Gen Education in the Higher Education Department

D. The Members of inspection teams shall be entitled for DA/TA as admissible under TA Rules.

E. The inspection team shall be allowed to hire vehicle for the intended inspection as per standing approved rates for hiring of private vehicles by the Government Department for official purposes.
