**Subject: Re-instatement of Services of Dr. Anil Gupta
I/c Principal.**

Government Order No: 330-HE of 2018.

Dated: 07-05-2018.

Whereas, Sh. Anil Gupta I/c Principal, Govt. Degree College, Akhnoor was transferred and posted as I/C Principal, Govt. Degree College, Kalakote vide Government Order No.66-HE of 2017 dated 26-10-2017 and was deemed to have been relieved;

Whereas, Sh. Anil Gupta I/c Principal did not join his duties at Govt. Degree College, Kalakote and remained on un-authorized absence from duties;

Whereas, Sh. Anil Gupta I/c Principal was placed under suspension vide Government Order No.58-HE of 2018 dated 01-02-2018 and Director Colleges was asked to charge sheet him and enquire /submit report within two weeks;

Whereas Director Colleges furnished preliminary findings in the case and recommended further course of action under CCA Rules.

Whereas, vide Order No.46-HE of 2018 dated 04-04-2018, an enquiry committee consisting of Director Colleges (HED) and Additional Secretary (HED) was constituted for a thorough enquiry into the matter. The committee was asked to submit its report/recommendations within one month;

Whereas, the enquiry Committee in its reports established that Sh. Anil Gupta I/c Principal had proceeded on medical leave by submitting the application to Director Colleges through e-mail. The officer did not bother to follow/know the status of his initial leave application but applied for extension of earned leave/medical leave from time to time. This depicts non serious behavior of a public servant towards his duties;

Whereas, in view of the health conditions (physical/ Psychological), the enquiry committee recommended that Sh Anil Gupta, i/c Principal may be re-instated, treating the suspension period as on earned leave with strong warning for not repeating such behavior in future

Now, therefore, sanction is hereby accorded to the re-instatement of Sh. Anil Gupta I/c Principal with immediate effect and treatment of his suspension period as leave whatever kind due to him. He shall remain careful in future and must not repeat such behavior in future.

Sh. Anil Gupta I/c Principal is attached with Nodal Principal, GGM Science College, Jammu till further orders.
