FINAL NOTICE

1. Whereas, J&K Public Service Commission vide letter No. PSC/DR/Asstt. Prof/113-14 dated 12-12-2017, recommended you among others for appointment as Assistant Professor (Pol. Science) in Higher Education Department; and
2. Whereas, J&K Higher Education Department vide Government Order No. 04-HE of 2018 dated 14-02-2018 accepted recommendations of J&K Public Service Commission and appointed you as Assistant Professor (Pol. Science) on regular temporary basis, in pay scale of Rs. 15600-39100 with GP of Rs. 6000/- and posted at GDC, Chatroo, with direction to report to concerned Principal within a period of 21 days from the date of issuance of appointment order, failing which your appointment shall be deemed to have been cancelled without any notice; and
3. Whereas, Nodal Principal, GGM Science College, Jammu vide letter dated 06-03-2018 intimated that you have not joined your services at your place of posting i.e. GDC, Chatroo within prescribed time and as such the post is lying vacant; and
4. Whereas, the Department served a Notice vide HE-Coll/Appt/Pol.Science/2017 dated 22-03-2018 to you with directions to report to Principal, Govt. Degree College, Chatroo within a period 10 days from the date of receipt of Notice or its publication in local News paper uploading on official website of Higher Education Department, whichever happens earlier, failing which your appointment shall be cancelled without any further Notice; and
5. Whereas, Principal, GDC, Chatroo vide his letter dated 09-04-2018 has informed that you have not joined your services even after sufficient opportunity was granted by Administrative Department.

Now, therefore, in view of above you are once again directed to report to your respective places of posting within a period of 10 days from the date of receipt of this notice/publication in local News paper/uploading on official website of Higher Education Department, whichever happens earlier failing which your appointment shall be cancelled.
