Salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) and (b) above is received.

The seniority of the appointee shall be maintained as per merit furnished by the Service Selection Board, J&K.

Further, if on verification, at any time, the certificates produced by the appointee prove fake or forged, the appointment shall be treated as cancelled ab-initio.

The appointment of above candidate shall, however, be subject to outcome of writ petition, if any pending in any court of law.
