Please refer to subject cited above, the Council has received email on 1<sup>st</sup> August, 2017 from Shri Feroz Ahmed, Under-Secretary, Department of Higher Education, Govt. of J&K, Srinagar regarding postponement of counseling scheduled from 4<sup>th</sup> – 6<sup>th</sup> August, 2017 at Srinagar. Accordingly, AICTE has postponed the counseling in the State of J&K during this period. SMS messages were also sent to all the students regarding postponement.

In the meanwhile, the Council has received information on the portal that numbers of seats under PMSSS are still vacant due to left-over or non-reporting of the students. The PMSSS Cell discussed the matter in detail for immediate remedial measures to benefit the students and it is decided that 2<sup>nd</sup> and 3<sup>rd</sup> Round of Counseling for the left-over seats will be done through on-line process as the time is very less.

**Grievance Redressal Mechanism:**


