In terms of J&K compassionate appointment rules notified under SRO-43 of 1994 dated 22-02-1994, sanction is hereby accorded to the appointment of Ms. Neha Bardwaj D/o. Late Raj Kumar R/o. Dhanore Jarallan Tehsil and District Rajouri as Laboratory Bearer on temporary basis in the pay band of Rs.4440-7440 with grade pay of Rs. 1300/- in Government Degree College, Thanamandi against an available post.


The appointee shall report to the Principal, Government Degree College, Thanamandi within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates to be verified subsequently:-

3. Health Certificate issued by the Competent Authority.
4. Permanent Resident Certificate.
5. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme

In case appointees fail to join within the stipulated period of 21 days, her appointment shall be cancelled without any further notice.

The appointment shall be subject to the following condition.

- a) The appointees shall give an undertaking duly attested by a Judicial Magistrate, to the effect that in case adverse report about her character and antecedents is received from the Inspector General of Police CID, Jammu and Kashmir to whom a reference shall be made by the department, her appointment shall be deemed to be cancelled ab-initio and she shall have no claim on his appointment.
