The appointment of the candidates shall be subject to the following conditions:

a. The appointees will be on probation for a period of two years from the date of joining in the respective Colleges.

b. The appointment of the candidates will be subject to verification of satisfactory character and antecedent by the CID.

c. Their salary shall not be drawn till satisfactory character and antecedent reports are received from the CID authorities. In case any adverse report is received, the appointment shall be deemed to have been cancelled without any notice.

- d. The appointees shall, at the time of joining, produce the following testimonials in original which will be verified by the Principal concerned before formally allowing them to join:
  - i. Permanent Resident Certificate.
  - ii. Date of Birth Certificate.
  - iii. Qualification Certificates i.e. NET/SET/Ph.D.
  - iv. Category certificate as may be applicable to the appointee.
  - v. A certificate from the Dy. Director Employment that the candidate has liquidated loan taken if any.

The Inter-se-seniority of the above candidates shall be issued later on as per their merit.

The appointment of the candidates shall be subject to outcome of writ petitions, if any pending, before any Court of law.
