As recommended by J&K Public Service Commission, sanction is hereby accorded to appointment of Shah Ubaid Ullah S/o Farooq Ahmad Shah R/o Bota Shah Mohalla, Near Qasmia, Lal Bazar, Srinagar, under Open Merit Category, as Assistant Professors (Bio-Technology), on regular temporary basis, in pay scale of Rs.15,600-39,100 with AGP of Rs.6000/- in Higher Education Department. **He is posted in Govt. Degree College for Boys, Baramulla.**

Appointment of Shah Ubaid Ullah shall be subject to following conditions:

- a. That he shall, at the time of joining, produce following testimonials in original to be verified by the Principal concerned before formally allowing him to join:
  - i. Permanent Resident Certificate.
  - ii. Date of Birth Certificate.
  - iii. Qualification Certificates i. e. NET/SLET/Ph.D.
  - iv. A certificate from the Director Employment that the candidate has liquidated the loan, if he taken.
- b. That he shall be on probation for a period of two years.
- c. That he shall report to the Principal concerned within a period of 21 days from the date of issue of this order failing which his appointment will be deemed to have been cancelled without any notice.
- d. His salary of appointee will be drawn only after a satisfactory report about his character and antecedents is received from Addl. Director General CID to whom a reference will be made on the prescribed declaration form of the candidate or a certificate of being already in Government service. In case any adverse report is received the appointment will be deemed cancelled without any notice.
- e. If on verification, at any time, the certificate produced by the appointee prove fake or forged, the appointment shall be treated as cancelled ab-initio.
- f. The appointment will also be subject to the outcome of the writ petitions if any are pending in the Hon'ble High Court of J&K.
