Whereas, J&K, Service Selection Board, vide letter No. SSB/Secy/Sel/2017/7942-48 dated 31-08-2017 and No.SSB/Sel/Secy/2017/8019-21 dated 05-09-2017, recommended following candidates for appointment as Junior Assistants under State Cadre, Open Category in Higher Education Department;

Whereas, J&K Higher Education Department vide Government Order No.549-HE of 2017 dated 19-09-2017 accepted recommendations of J&K Service Selection Board and appointed the above mentioned candidates as Junior Assistants on regular temporary basis, in pay scale of Rs.5200-20200+GP Rs.1900/- with the direction to join in the Administrative Department (HED) within a period of 21 days from date of issuance of appointment order failing which their appointment shall be deemed to have been cancelled without any notice; and

Whereas, above mentioned candidates did not join their services within prescribed period of time and as such the posts are lying vacant in the Department; and

Whereas, this Department served a Notice vide HE-Appt/JA/State Cadre/2014 dated 25-10-2017 to above said appointees with directions to join their services within period of 10 days from the date of receipt of Notice or its publication in local News paper, uploading on official website of Higher Education Department, whichever happens earlier, failing which their appointment shall be cancelled ab-initio without any further Notice; and

Whereas, both the appointees have not joined their services even after sufficient opportunity was granted by Higher Education Department.

Now, therefore, in view of above appointment of Mr. Surinder Singh S/o Khem Singh R/o Camp Gole Gujral Near Gurudwara Sahib Talab Tillo, Jammu and Mr. Kawaldeep Singh S/o Jasbir Singh R/o Camp Gole Gujral Mohalla Sachkhand, Jammu as Junior Assistants in Higher Education Department is hereby cancelled in-abitio.
