Whereas, the Higher Education Department accept the recommendation of J&K Services Selection Board Ms. Taru Mahajan D/o. Sh. Vishnu Gupta R/o. H.No.113 Trikuta Nagar, Jammu appointed as "Senior Laboratory Technician, Electronics & Communication Engineering" (Divisional cadre Jammu) in the Higher Education Department vide Government Order No. 716-HE of 2017-HE of 2017 dated 28-12-2017;

Whereas, the Principal, Government College of Engineering & Technology, Jammu vide letter No. GCET/2018/Adm/183 dated 30-01-2018 has informed that Ms. Taru Mahajan newly appointed as Senior Laboratory Technician (Electronics & Communication) has not joined the College so far;

Whereas, the above appointee fail to join the respective College within the stipulated time;

Now, therefore, the appointment of Ms. Taru Mahajan D/o. Sh. Vishnu Gupta as Senior Laboratory Technician (Electronics & Communication Engineering) ordered vide Govt. No. 716-HE of 2017 dated 28-12-2017 is hereby cancelled ab-initio.
