**Subject: Treating of un-authorized period as Dies-non.**

**Government Order No: 607 HE of 2017.**  
**Dated : 16 -10- 2017.**

Whereas, Mr. Fayaz Ahmad Lone was appointed as Assistant Professor (Commerce) vide Govt. Order No.106-HE of 2017 dated 15-02-2017 pursuant to recommendations of J&K Public Service Commission. He was posted in Govt. Degree College for Boys, Pulwama, where he joined on 03-03-2017; and

Whereas, Mr. Fayaz Ahmad Lone, Assistant Professor (Commerce) applied for one month leave w.e.f. 13-03-2017 along with station permission for proceeding outside Country before Principal GDC Boys, Pulwama; and

Whereas, after three months, Principal, Govt. Degree College for Boys, Pulwama vide his communication dated 19-06-2017 informed Administrative Department that Mr. Fayaz Ahmad Lone, Assistant Professor (Commerce) joined back in the College on 15-06-2017 and Principal concerned forwarded his related documents to the Administrative Department for further course of action; and

Whereas, Principal, Govt. Degree College for Boys, Pulwama vide this Department's letter dated 03-08-2017 was requested to allow Mr. Fayaz Ahmad Lone, Assistant Professor (Commerce) to join in the College and also ask him why the excess period spent by him un-authorizedly may not be treated as "Dies-non";and

Whereas, Principal, Govt. Degree College for Boys, Pulwama vide his office letter No.GDC/Pul/Explanation/860 dated 16-08-2017 served an explanation to Mr. Fayaz Ahmad Lone, Assistant Professor (Commerce) for remaining un-authorizedly absent from duty w.e.f. 13-03-2017 to 14-06-2017; and

Whereas, Mr. Fayaz Ahmad Lone, Assistant Professor (Commerce) prelisted he had proceeded to Saudi Arabia for completing legal formalities as prior to his appointment in Higher Education Department he was working as Assistant Professor from for the last four years in Prince Sattam Bin Abdulaziz University, Saudi Arabia and simultaneously requested that the period w.e.f. 13-03-2017 to 14-06-2017 may be treated as leave without pay instead of dies-non; and

Whereas, his plea has been examined in the Department and was observed that the faculty member has not brought the facts in the knowledge of competent authority before his departure to Saudi Arabia and his visit outside Country was un-authorized; and

Now, in view of above the un-authorized absence from duty w.e.f. 13.03.2017 to 14.06.2017 by Mr. Fayaz Ahmad Lone, Assistant Professor (Commerce), Govt. Degree College for Boys, Pulwama is hereby treated as "Dies-non" and his period of probation is extended w.e.f. 15-06-2017, accordingly.
