The candidates who fail to join within a period of 21 (twenty one) days from the date of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice.

The appointment of the candidates shall be subject to the following conditions:-

- The appointees will be on probation for a period of two years from the date of joining.
- The appointment of the candidates will be subject to verification of satisfactory character and antecedent by the CID.
- Their salary shall not be drawn till satisfactory character and antecedent reports are received from the CID authorities. In case any adverse report

is received, the appointment shall be deemed to have been cancelled without any notice.

 - i. Permanent Residential Certificate/Domicile Certificate.
 - ii. Date of Birth Certificate.
 - iii. Academic Qualification Certificates.
 - iv. Additional Qualification Certificate i.e. NET/SLET/Ph.D.
 - v. Category certificate as may be applicable to the appointee.
 - vi. Health Certificate issued by the competent authority.
 - vii. A certificate from the Director Employment that the candidates has liquidated loan taken if any.

The inter-se-seniority of the above candidates shall be issued later on as per their merit.

The appointment of the candidates shall be subject to outcome of writ petition(s), if any pending, before any court of law.
