Whereas, the said faculty member had performed her duties in the Higher Education Department upto 17.04.2017 i.e the date she had submitted her formal resignation from the post of Assistant Professor, Functional English, Amar Singh College, Srinagar consequent upon her appointment as Assistant Professor, in the Department of Linquistic, University of Kashmir issue vide Order No.KU/RECT/appointment/17 datged 17.04.2017;and

Whereas, at the time of applying for the post of Assistant Professor in the University of Kashmir, she was not borne on the rolls of the Higher Education Department, as such, she had not applied for the said post through the proper channel; and

Whereas, Amar Singh College, Srinagar has communicated that there is nothing outstanding or adverse report, as per records against the said faculty member; and

Whereas, Dr. Sheeba Hassan, Assistant Professor, Department of Linguistic, University of Kashmir has requested that her resignation may kindly be accepted w.e.f. 17.04.2017;and

Whereas, the case was examined in the Higher Education Department and placed before the Competent Authority for acceptance of the technical resignation tendered by Dr. Sheeba Hassan, the then Assistant Professor, Functional English, A.S.College, Srinagar; and

Whereas, the Competent Authority has accepted the resignation of the ex-Assistant Professor, Higher Education Department.

Now, therefore, consequent upon the above and in terms of Article 200 of the J&K Civil Service Regulations, Volume-I, the resignation tendered by Dr. Sheeba, Hassan, the then Assistant Professor, Functional English, Amar Singh College, Srinagar is hereby accepted w.e.f. 17-04-2017 and her lien on the said post shall also be deemed to have been terminated from the said date.
