 - c. Qualification and Marks Certificate i.e. NET/SLET/Ph.D. etc and Marks cards/Degrees.
 - d. Category certificate as may be applicable to the appointee.
 - e. Health and Medical Certificate.
 - f. Any other certificate as required under law.

The salary of the appointee shall be drawn and disbursed only after the receipt of the satisfactory report in respect of genuineness of the Qualification/Date of

The inter-se-seniority of the candidate shall be determined in terms of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956.

In case any certificate is found to be fake, inadequate or not consistent with the eligibility requirements, the appointment of the candidate shall be deemed to have been cancelled ab-initio.
