As per the approval of the Competent Authority for relaxation of Rule 58 of the Jammu and Kashmir Public Service Commission (Business & Procedure) Rules, 2021, and in continuation of Government Order No. 90-JK (HE) of 2022 dated 18-04-2022, sanction is hereby accorded to the appointment of Mr. Muzaffar Ahmad Sheikh, son of Mohd Abdullah Sheikh, resident of 58, Dalwach, Gasigund, Qazigund, Dooru, under the RBA category, as Assistant Professor (Water Management) on a Regular Temporary basis in the Pay Band of Rs.15,600-39,100 with an AGP of Rs. 6,000/- (pre-revised) at Academic Level-10, with a pay structure of Rs. 57,700/-, in the Higher Education Department, notionally w.e.f 18.04.2022 and monetarily with immediate effect.

The appointee shall report to the Nodal Principal, Government College of Education, Srinagar within a period of 21 days from the date of issuance of this order, failing which his appointment shall be deemed to have been cancelled without any notice.

The appointment of the candidate shall be subject to the following conditions:-

- i. The appointee will be on Probation for a period of Two years from the date of joining.
- ii. The appointment of the candidate shall be governed by the New Pension Scheme as per SRO-400 of 2009 dated 24.12.2009.
- iii. The appointee shall at the time of joining, produce the following testimonials in original which will be verified by the concerned Principal:-
- iv. Domicile Certificate.
- v. Date of Birth Certificate.
- vi. Qualification and marks Certificates i.e. NET/SLET/Ph.D etc and marks cards/degrees.
- vii. Health and Medical Certificate.
- viii. Category Certificate as may be applicable to the appointee.
- ix. Any other certificate as required under Law.
- x. A certificate from the Director Employment that the candidates has liquidated loan taken, if any.



The salary of the appointee shall be drawn and disbursed only after the receipt of the satisfactory report in respect of genuineness of Qualification/Date of Birth/relevant Category Certificate and subject to production an Affidavit annexed as Annexure-A to this Order.

The Inter-se-Seniority of the candidate shall be determined in terms of the J&K Civil Services (Classification Control & Appeal Rules), J&K, 1956.

The appointment of the candidate shall remain provisional till such time the certificates are got verified by the concerned Principal and are found to be in order. In case any certificate is found to be fake, inadequate or not consistent with the eligibility requirements, the appointment of the candidate shall be deemed to have been and cancelled ab-initio.

The appointment of the candidate shall, however, be subject to outcome of Writ petition(s), if any, filed in the matter pending before the Court of Competent jurisdiction.




