The salary of the appointee shall be drawn and disbursed only after the receipt of the satisfactory report in respect of genuineness of Qualification/Date of Birth/ Relevant Category Certificate and subject to production of an Affidavit as per Annexure-A to this order.

The inter-se seniority of the candidate shall be determined in termof the J&K Civil Services (Classification, Control & Appeal) Rules, 1956.

The appointment of the candidate shall remain provisional tillsuch time as the certificates are got verified by the concerned Principal and found to be in order. In case any certificate is found to be fake, inadequate or not consistent with eligibility requirements, the appointment of the candidate would be deemed to have been cancelled ab-initio.

The appointment of the candidate shall be subject to outcome of Writ Petition(s), if any, pending before the Court of law.
