As per approval of the Competent Authority/recommendations of the J&K Public Service Commission and in continuation of the Government Order No. 127-JK(HE) of 2022 dated 18.05.2022, sanction is hereby accorded to the appointment of Ms. Ryhana Abdullah D/o Mohamad Abdullah Kumar R/o Redwani Balla, Alamdar Mohalla, Qoimoh under RBA Category as Assistant Professor (Home Science) on Regular Temporary Basis in the Pay Band of Rs.15600-39100 with AGP Rs.6000/- (Pre-revised) Academic Level-10 with Pay Structure of Rs.57700/-) In the Higher Education Department, notionally w.e.f 18.05.2022 and monetarily with immediate effect.

The appointee shall report to the Nodal Principal, Government College of Education, Srinagar within a period of 21 days from the date of issuance of the order falling which her appointment shall be deemed to have been cancelled without any notice.

The appointment of candidate shall be subject to the following conditions:-

1. The appointees will be on probation for a period of two years from the date of joining.
2. The appointment of the above candidates shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24-12-2009.
3. The appointees shall, at the time of joining, produce the following testimonials in original which will be verified by the concerned Principal:-

- a. Domicile Certificate.
- b. Date of Birth Certificate.
- c. Qualification Certificates i.e. NET/SLET/Ph.D.
- d. Category certificate as may be applicable to the appointee.
- e. A certificate from the Director Employment that the candidates has liquidated loan taken, if any

The salary of the appointee shall be drawn and disbursed only after the receipt of the satisfactory report in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and subject to production of an Affidavit as per **Annexure-A** to this order

The inter-se seniority of the candidate shall be determined in terms of J&K Civil Services (Classification, control and Appeal), Rules, 1956.

The appointment of the candidate shall remain provisional till such time as the certificates get verified by the concerned Principal and found to be in order. In case any certificate is found to be fake, inadequate or not consistent with eligibility requirements, the appointment of the candidate would be deemed to have been and void ab-initio.

The appointment of the candidate shall be subject to outcome of writ petition(s), if any, pending before the Court of Law.
