Guidelines for nomination for B.Sc. Nursing and Architecture courses.

1. Residence:-

Applicant should be a bonafide citizen of the State of J&K.

2. Nomination

The nomination shall be made by Hon'ble Minister for Higher Education from amongst the eligible candidates possessing prescribed qualification with good academic record. The candidate shall not have been selected in any other course on nomination basis in any department/institute.

3. Qualification:

- a) **B.Sc Nursing course:**-The applicant should have passed Higher Secondary part-II/Senior Secondary/Intermediate (10+2) or an equivalent examination from a recognized Board or University in Science/Medical subject viz, Physics, Chemistry, Biology and General English as main subjects.
- b) **B.Architecture course:** The applicant should have passed Higher Secondary Part II/Senior Secondary/Intermediate (10+2) or an equivalent examination from a recognized Board or University in Science/Non-Medical subjects viz. Physics, Chemistry, Mathematics/Statistics and General English as main subjects.

4. Medical Fitness

The candidate should be physically/medically fit for which a certificate of the competent authority shall be mandatory.

5. Fee

The candidate(s) have to pay the fee as per the fee structure in vogue/approved by the competent authority for the said course(s).
