**Subject:- Increase of wages of Daily Wager Earners.**

**C I R C U L A R**

Whereas, on the basis of Cabinet Decision No.113/10/2009 dated 29-08-2009. The Finance Department vide Government Order No.190-F of 2009 dated 31-08-2009 authorized payment of Rs.110/- (Rupees One Hundred & Ten) per day with effect from 10<sup>th</sup> August 2009 in favour of all authorized Daily Wage Earners working in all Government Departments and those of Municipalities and Local Bodies.


Whereas, the Labour & Employment Department notified the minimum wages of Daily Wage Earners under SRO 304 of 1<sup>st</sup> October, 2009.

Whereas the Higher Education Department endorsed the Government Order No.190- F of 2009 dated 31-08-2009 to all Principals of Government Degree Colleges of both the Jammu/Kashmir Province for payment of wages to local fund employees working in their Colleges in accordance with the orders issued by the Finance Department.

Whereas, vide this Department Circular No.Ec/Coll/NGK/Wages/LF/09 dated 09-12-2009, it was again enjoined upon all the Principals of the Government Degree Colleges to pay wages in favour of local fund employees working in their Colleges at the minimum rates @ Rs./110/- per day.

Whereas, it has come to the notice that some Principals of the Degree Colleges have not implemented the orders/instructions passed by the Government from time o time and are not paying the wages of local fund employees working in their Colleges at the minimum rate of Rs.110/- per day.

Now, therefor, it is again impressed upon all the Principals to ensure the payment of wages in favour of local fund employees at the revised rates as mentioned hereinabove and implement the orders passed by the Finance Department endorsed by this Department, in its letter and sprit, under intimation to this Department.
