Subject: Cancellation of the appointment of Mr. Zameer Ahmad Wani S/o Abdul Gani Wani R/o 423 Sahibabad, Achabal, Anantnag, made as Assistant Professor, Electronics in the Higher Education Department.

Government Order No. 514 JK(HE) of 2024 Dated: 3\-10-2024.

Whereas, the J&K Public Service Commission vide letter No. PSC/DR-HE/AP-Electronics/2023 dated. 08-04-2024 had recommended the name of Mr. Zameer Ahmad Wani S/o Abdul Gani Wani R/o 423 Sahibabad, Achabal, Anantnag under OM Category alongwith other 07 candidates for appointment as Assistant Professor (Electronics) in the pay scale of Rs.15600-39100 with AGP of Rs.6000/-; and

Whereas, the Higher Education Department vide Government Order No. 374-JK (HE) of 2024 dated 09-07-2024 issued appointment order in favour of Mr. Zameer Ahmad Wani S/o Abdul Gani Wani R/o 423 Sahibabad, Achabal, Anantnag under OM Category after getting satisfactory report from the CID, with the directions to report to the Nodal Principal, A.S. College, Srinagar within a period of 21 days from the date of issuance of the order, failing which the appointment shall be deemed to have cancelled without any further notice; and

Whereas, the Nodal Principal, Kashmir vide her office letter dated 08-10-2024 intimated that Mr. Zameer Ahmad Wani S/o Abdul Gani Wani R/o 423 Sahibabad, Achabal, Anantnag has not joined in pursuance to the Government Order No. 374-JK (HE) of 2024 dated 09-07-2024; and

Whereas, the Higher Education Department issued a Notice to Mr. Zameer Ahmad Wani dated 19-09-2024 with the directions to immediately join the concerned College within a period of 07 days from the date of its publication, but he has not responded to that Notice and failed to join; and

Whereas, as per Circular No.08-JK (GAD) of 2019 dated 04-12-2019 under Endorsement No.GAD(Ser)Genl/Circ/06/01 dated 04-12-2019 issued by the General Administration Department, it has been provided that the candidates who fail to join within a period of 21 days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice;

Now, therefore, consequent upon the above, the appointment of Mr. Zameer Ahmad Wani S/o Abdul Gani Wani R/o 423 Sahibabad, Achabal, Anantnag made as Assistant Professor (Electronics) under OM Category vide Government Order No.374-JK (HE) of 2024 dated 09-07-2024 issued by the Higher Education Department so far as the same pertains to him shall be deemed to have been cancelled ab-initio.
