Subject: Cancellation of the appointment of Ms. Seerat Baji, D/o Mushtaq Hussain, H.No. 61 Lane No. 3, Vidhata Nagar Bathindi Road, Jammu made as Assistant Professor, English under ST category in the Higher Education Department.

Whereas, the Jammu & Kashmir Public Service Commission had vide letter **PSC/DR-HE/AP-English/2023** dated 29-01-2024 recommended the name of 40 candidates under different categories for their appointment as Assistant Professors, English, in the Higher Education Department wherein name of Ms. Seerat Baji was also figuring in the list at Serial No. 02 under ST Category; and

Whereas, vide this Department's Notice dated **29.02.2024**, all the selected candidates were advised to furnish their bio-data including email ID and contact number for conduct of CID verification of their Character and Antecedents; and

Whereas, all the applicants including Ms. Seerat Baji had submitted the requisite details to the Department which were uploaded on the verification portal; and

Whereas, after receiving the CID verification report the Higher Education Department has vide Government Order No.327-JK(HE) of 2024 dated 06-06-2024 issued in continuation to the Government Order No.196-JK(HE) of 2024 dated 16.03.2024 read with Government Order No. 198-JK(HE) of 2024 dated 16.03.2024 issued appointment orders among others in favour of Ms. Seerat Baji, D/o Mushtaq Hussain, H. No. 61 Lane No. 3, Vidhata Nagar Bathindi Road, Jammu; and

Whereas, subsequently the Nodal Principal, Jammu vide his office letter dated 21.06.2024 has intimated that Ms. Seerat Baji, Assistant Professor, English, has not submitted her joining in the Government College for Women, Gandhi Nagar, Jammu till date, which has necessitated cancellation of her appointment orders made as Assistant Professor, English, Higher Education Department; and

Whereas; Ms. Seerat Baji, D/o Mushtaq Hussain, H.No. 61 Lane No. 3, Vidhata Nagar Bathindi Road, Jammu (Selected candidate under ST Category) has submitted an application alongwith an undertaking/affidavit showing her unwillingness/withdrawal of candidature to join as Assistant Professor, English in the Department. She has also mentioned therein that she is not interested to join the said post and has no objection, if next candidate in the order of merit is cleared against the said post of Assistant Professor and for that she will not stake any claim in future for the said post.

Now therefore, consequent upon the above, it is hereby ordered that the appointment of Ms. Seerat Baji, D/o Mushtaq Hussain, H.No. 61 Lane No. 3, Vidhata Nagar Bathindi Road, Jammu as Assistant Professor, English, under the ST Category, in the Higher Education Department vide Government Order No. 327-JK(HE) of 2024 dated 06.06.2024, so far as the same pertains to her (Serial No. 18), shall and shall be deemed to have been cancelled ab-initio.
