**Subject: Appointment of Assistant Professors (Computer Application) in Higher Education Department by operating wait list.**

**Government Order No. 295 - HE of 2017.**

Whereas, Jammu and Kashmir, Public Service Commission vide communication No.PSC/DR/AP/Comp.App/113-14 dated 25-11-2016 recommended 57 candidates for appointment to the posts of Assistant Professors (Computer Application) in Higher Education Department; and

Whereas, vide Government Order No.371-HE of 2016 dated 13-12-2016, this Department accepted recommendations of J&K Public Service Commission and appointed 57 candidates on regular temporary basis, with the directions to join within 21 days from the date of issuance of appointment order failing which their appointment shall be deemed to have been cancelled without any notice; and

Whereas, following appointees failed to join their services within stipulated time, despite sufficient opportunity granted by this Department vide Notice No. HE-Coll/Appt/AP/Comp.Appl./PF dated 03-03-2017. Subsequently their appointments were cancelled vide Govt. Order No.244-HE of 2017 dated 24-04-2017:

Candidates hailing from Kashmir Division shall report to Nodal Principal, A.S. College, Srinagar and candidates hailing from Jammu Division shall report to Nodal Principal, GGM Science College, Jammu.

Their appointment shall be subject to following conditions:

- a. appointees shall, at the time of joining, produce following testimonials in original to be verified by the Principal concerned before formally allowing them to join:
  - i. Permanent Resident Certificate.
  - ii. Date of Birth Certificate.
  - iii. Qualification Certificates i. e. NET/SLET/Ph.D.
  - iv. A certificate from the Director Employment that the candidate has liquidated the loan, if he/she taken.
- b. appointees shall be on probation for a period of two years.
- c. They will report to Principal concerned within a period of 21 days from date of issue of this order failing which their appointment will be deemed to have been cancelled without any notice.
- d. salary of the appointees will be drawn only after a satisfactory report about their character and antecedents is received from Addl. Director General CID to whom a reference will be made on the prescribed declaration form of the candidate or a certificate of being already in Government service. In case any adverse report is received the appointment (s) will be deemed cancelled without any notice.
- e. If on verification, at any time, the certificates produced by the appointees prove fake or forged, their appointment shall be treated as cancelled ab-initio.
- f. The appointments will also be subject to the outcome of the writ petitions, if any are pending in the Hon'ble High Court of J&K
