Their appointment shall be subject to following conditions:

- a. Appointees shall, at the time of joining, produce following testimonials in original to be verified by the Principal concerned before formally allowing them to join:
  - i. Permanent Resident Certificate.
  - ii. Date of Birth Certificate.
  - iii. Qualification Certificates i. e. NET/SLET/Ph.D.
  - iv. A certificate from the Director Employment that the candidate has liquidated the loan, if he/she taken.

- b. Appointees shall be on probation for a period of two years.
- c. They will report to Principal concerned within a period of 21 days from date of issue of this order failing which their appointment will be deemed to have been cancelled without any notice.
- d. Salary of the appointees will be drawn only after a satisfactory report about their character and antecedents is received from Addl. Director General CID to whom a reference will be made on the prescribed declaration form of the candidate or a certificate of being already in Government service. In case any adverse report is received the appointment (s) will be deemed cancelled without any notice.
- e. If on verification, at any time, the certificates produced by the appointees prove fake or forged, their appointment shall be treated as cancelled ab-initio.
- f. The appointments will also be subject to the outcome of the writ petitions, if any are pending in the Hon'ble High Court of J&K.
