- vi. That he shall not avail any financial support or hospitality from any Govt./Semi Govt. or professional body.
- vii. That the DDO concerned shall make necessary entries regarding availing of any kind of Leave and Foreign Visit in the Service Book of the Faculty Member.
- viii. That he shall not involve himself in any anti national or subversive activities there.
- ix. That he shall abide the J&K Civil Services (CC&A) Rules, 1956.
- x. That he shall not leave the station prior to the sanction of leave for the aforesaid period from the Competent Authority.
