- iv. That he will not carry out any commercial activity or obtain any consultancy/employment during his stay at Saudi Arabia.
- v. That the visit will be purely private and shall not be clubbed with any official/semi official activity.
- vi. That no financial support or hospitality from any Govt./Semi Govt. or professional body shall be availed.
- vii. That the DDO concerned shall make an entry regarding availing of the kind/quantum of Leave for the aforesaid period and Foreign Visit in the Service Book of the Faculty Member.
- viii. That he shall not involve himself in any anti national or subversive activities there.
- ix. That he shall abide the J&K Civil Services (CC&A) Rules, 1956.
- x. That the Faculty Member shall not leave the station prior to the sanction of the Leave for the above period by the Competent Authority.
