Subject: 141/2024 Titled Ajmair Singh Sodhi Vs UT of J&K &Ors- Compliance of Order thereof.

Government Order No. 485 - JK (HE) of 2024
Dated: 09.10.2024

Whereas, applications were invited through online portal for effecting transfers of Assistant Professor, Associate Professor, Physical Training Instructor and Librarian. Detailed instructions were issued for applying through online Portal; and

Whereas, the Applicant Ajmair Singh Sodhi, Assistant Professor in Industrial Fish and Fisheries applied through online portal and he was transferred from Government Degree College Baramulla to Government Degree College Kathua vide Government Order No. 119-JK(HE) of 2024 dated 28.02.2024 ;and

Whereas, the applicant being aggrieved of the Government order No. 119-JK(HE) of 2024 dated 28.02.2024 filed 141/2024 Titled Ajmair Singh Sodhi Vs UT of J&K & Ors before the Hon'ble Central Administrative Tribunal, Srinagar praying for following reliefs:-

- i. A direction in favour of the applicant for quashing and setting aside the order impugned order No. 119-JK(HE) of 2024 dated 28.02.2024 issued by respondents.
- ii. A command is issued directing the respondents not to relieve the applicant from present place of posting;

Whereas, the Hon'ble Central Administrative Tribunal after hearing the applicant disposed the OA by passing order dated 04.03.2024, the operative part of which is reproduced as under:

".....In View of the limited prayer made by the learned counsel for the applicant respondents are directed to consider the representation of the applicant dated 01.03.2024 in accordance with law and retain the applicant at the present place of posting or nearby Degree College, Bemina specially taking into consideration that the son of the applicant is being given a proper treatment in SKIMS Bemina, within four weeks from the date of passing of a copy of this order, by passing a reasoned and speaking order. Till then the applicant shall not be relieved from his present place of posting if he is not already relieved.

With these directions, O.A. No. 141/2024 is disposed of."

Whereas, a detailed representation has also been forwarded by the Office of the Hon'ble Advisor(B), wherein the Applicant has stated that, in addition to his ailing aged parents, his three-year-old son is suffering from Attention Deficit Hyperactivity Disorder (ADHD). In simple terms, this condition necessitates special treatment and therapy, requiring regular counseling by a well- trained counselor or psychotherapist. His son's treatment is currently being administered at SKIMS Srinagar, and in the Applicant's absence, the child would be deprived of necessary medical care; and



Whereas, in compliance with the directions of the Hon'ble Central Administrative Tribunal, and upon receipt of the Applicant's representation, the matter has been thoroughly examined by the Department, and it has been determined that the Applicant's case is genuine and warrants positive consideration.

Now, therefore, in light of the aforementioned facts and circumstances, and taking into account the medical condition of the Applicant's son, it is hereby ordered that the Applicant shall be retained at his present place of posting to ensure the continuation of his son's treatment.




