Subject: Unauthorized absence from duty

SHOW CAUSE NOTICE

Whereas, you were appointed as Assistant Professor (Electronics) in Higher Education Department vide Government order No. 190-HE of 2005 dated 26-09-2005 and were posted at GGM Science College, Jammu and

Whereas you had applied for grant of permission to pursue Ph.D on part time basis in Physics from Indian Institute of Technology (IIT), Delhi; vide application dated 04-12-2014.

Whereas, the case was forwarded to Higher Education Department by concerned Principal with the remarks that you may pursue research during holidays and vacations; and

Whereas the Department had already taken a stand to disallow faculty members to pursue part time research through Universities located outside the state as it does not seem feasible for a regular faculty member to carry on the teaching work and research work at distantly located institutions simultaneously. Further, if a candidate is still interested in pursuing Ph.D through Universities outside the state he/she may apply to UGC for award of teacher fellowship under FIP Scheme of UGC. Hence your case was finally rejected and accordingly Principal, GGM Science College, Jammu vide this Department's letter dated 10-07-2015 was requested to convey you that your request for grant of permission for pursuing Ph.D on part time basis from IIT, Delhi, was not agreed to, and

Whereas, Principal, Science College, Jammu vide letter dated 28-02-2017 while furnishing workload of Jammu Division Colleges for grant of confirmation for academic arrangement candidates for session 2016-17, intimated that you were out of country and your salary has been stopped since October 2015, which clearly indicates that you have not complied by the decisions of Higher Education Department and left your services un-authorizedly and are continuing to remain un-authorizedly absent from your duties since October 2015, and

Now, therefore, keeping in view the above stated position, you are directed to explain as to why action warranted in terms of Article 128 of the J&K Civil Service Regulations may not be initiated against you, which may tantamount to termination of your appointment. The reply to notice must reach this office within 10 days from the date of publications or receipt of this Notice whichever is earlier, failing which it shall be presumed that you have nothing to say in your defense.
