On the recommendations of J&K Services Selection Board, and as conveyed by General Administration Department, sanction is hereby accorded to the temporary appointment of **Mr. Muneeb Ahmad S/o Ahmadullah Wani R/o Gadiser Bon Marg Dachnipora, District Anantnag** under category **OM/HCV in Kashmir Division** as Class-IV (Multi Tasking Staff) in the Pay Level SL-1(14800-47100) in the Higher Education Department.

The appointee shall report to Director Colleges, J&K within 21 days from the date of issuance of this order, and if he fails to join within the stipulated time, shall forego his right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join only on the production of the following certificates (in original) to be verified subsequently:

- i. Academic Qualification Certificates.
- ii. Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate.
- v. Certificate of Physical Disability.
- vi. Any other certificate required.

The appointment of the appointee shall further be subject to the following conditions:-

- a. That he shall give an undertaking in the shape of an Affidavit to the effect that if on verification, his Qualification/Date of Birth/Category Certificates, if any, from the

concerned issuing authority are found to be fake/forged, the claim of the appointee for appointment as Class-IV/MTS shall be deemed to have been cancelled ab-initio and legal action as warranted under rules shall be initiated against him.

- b. That if the candidate has taken loan for self employment from DIC/ Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling centre of the domicile District, he shall relinquish the proprietorship of unit/ enterprise and also stakes, if any, in such self-employment unit / enterprise before joining the Government Service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/ enterprise and recovery to be made and also personally monitor its recovery.
- c. The salary of the appointee shall not be drawn and disbursed to him unless a satisfactory report in respect of genuineness of Qualification/Date of Birth/Category Certificate, if any, is received from the concerned Authorities.
- d. The appointee shall be on probation for a period of two years.
- e. The appointment of candidate shall be governed by the " New Pension Scheme" as notified vide SRO-400 of 2009 dated 24-12-2009.
- f. The appointee shall furnish an undertaking in the shape of an Affidavit to the effect that the appointee has no criminal records and also not facing any criminal proceedings in any court of law as per Annexure-A to this Order.
- g. The appointment of the above appointee shall be subject to outcome of writ petition(s), if any pending before the Competent Court of Law.




